Submissions

All manuscripts for the Journal of Information & communication Technology should be submitted electronically through email to the editor at <code>jict@ibt.edu.pk</code>. Manuscripts should be prepared in US English using a word processing (preferably in MS Word) program and saved as a .doc or .rtf file. The attached file should be named according to the title of your article and it should mention 'Research paper submission' in the subject of the email.

GUIDELINES FOR AUTHORS

MANUSCRIPT SPECIFICATIONS

Abstract: All manuscripts should contain a well-summarized abstract of 100 to 200 words. This should be in a separate file of the soft copy and a separate page on hard copy.

Title Page: This includes the title of the article, complete name(s) of author(s), active email(s) and institutional affiliation(s) respectively and acknowledgements and/or any other special note (if given).

General Format and Style: The manuscripts should be formed in double space, with 1.25-inch margins on all sides on A4 size page. The text as well as footnotes should be written in Times New Roman font of size 12 point. Multiple columns shouldn't be used. In case of using special characters or symbols, not available in Microsoft Word, or Adobe Acrobat, the true type font(s) files should be attached.

Tables and Figures: Figures, tables and boxes should be numbered consecutively in Arabic numeral, (e.g.; Figure 1, Figure 2, and Table 1, Table 2, etc.). Colorful customized figures and graphs shouldn't be drawn and figures and tables shouldn't be inserted in the main text. Instead, in the space immediately after the paragraph in which the figure or table is first referenced, insert a text tag may be inserted: [Figure 1 here]. Soft copy of figures/graphs and tables should be vaccompanied with the soft copy of the manuscript in Microsoft Excel or any other compatible format, in files separate from the text file(s).

Data and Programming Routines: Data used in the article should be separately provided along with the soft copy in any standard spreadsheet format. If the manuscript is supported by any econometric computations or mathematical estimation then the software should be named with version and relevant estimation file and/or program routines should be sent.

Footnotes: All footnotes should be numbered in Arabic numeral, corresponding to numbers in the text, and placed at the bottom of the page rather than at end of the manuscript.

Reference List and Citations: Authors are requested to follow the Chicago Style of Manual for reference and citation and list of references be placed alphabetically by author's last name and then by year. Please refer name of all authors for collecting work and avoid using et al. in lieu of authors' name. Please do not use abbreviation for name of journals or conference or books. Please clearly mention the website of the cited article or give details regarding an unpublished work not included in proceedings, journals or books.
